PAYMENT METHOD FOR NON-THESIS MASTER'S PROGRAM TUITION FEES : Half of the program fee will be paid during the final registration to the program, and the other half will be paid at the beginning of the second semester within the periods specified in the academic calendar, and no fee will be charged in the third semester if the student stays in the third semester, provided that the full program fee has been paid. However, if the student does not pay the fee at the beginning of the second semester, he/she can pay it with a 20% increase at the beginning of the third semester. These fees will be applied to students enrolled in the 2023-2024 academic year.

PAYMENT METHOD FOR MASTER'S PROGRAMS WITH THESIS (EVENING EDUCATION): The fee for each semester will be paid within the dates specified in the academic calendar at the beginning of each semester.

*** TUITION FEES FOR TURKISH CITIZEN STUDENTS IN MASTER'S (DAYTIME EDUCATION) AND PH.D. PROGRAMS:** Only Turkish citizen students who are registered in another higher education institution and exceed the normal duration of study are required to pay a tuition fee. These fees are determined every year by Presidential Decree. The fees will be paid within the dates specified in the academic calendar at the beginning of each semester.

PAYMENT METHOD FOR INTERNATIONAL STUDENTS' TUITION FEES IN MASTER'S (DAYTIME EDUCATION) AND PH.D. PROGRAMS: The normal education period (the first-semester fee will be paid during the final registration) and at the beginning of the semester for each extended semester within the periods specified academic calendar.

EXPLANATIONS

- The graduate tuition fees stated above will not apply to current students who enrolled before the 2023-2024 Fall semester.** These students will be responsible for paying their previous fees.
- The semester fees for Master's (with thesis) and Ph.D. programs can be updated to cover all students before the start of each academic year, and all students enrolled in the 2023-2024 Fall semester and later will be subject to these new fees.
- If there are no updates made to the tuition fees, the previously determined fees will remain valid.
- Since the tuition fees for Non-Thesis Master's programs are determined as the total program fee, students are required to pay the program fee determined for the academic year they register.
